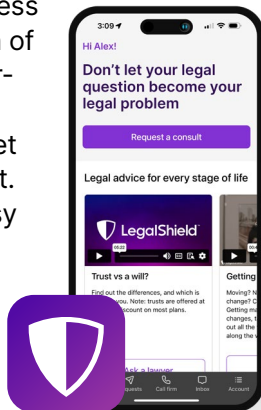

Features For Your Premium Legal Plan

The Premium Legal Plan Covers:

- ✓ The member and member's spouse or domestic partner.
- ✓ Never married dependent children under age 26 living at home or full-time students.
- ✓ Dependent children under age 18 for whom the member is legal guardian.
- ✓ Physically or mentally disabled children living at home.

Advice and Consultation

Phone consultations with your law firm for an unlimited number of personal legal matters, even pre-existing matters.

Letters & Phone Calls on your Behalf

One phone call or letter for each unrelated personal legal matter if necessary. One follow-up letter or phone call.

Legal Research

Your provider law firm may provide up to one hour of legal research per personal legal matter.

Contract/Document Review

Your provider law firm can review an unlimited number of personal legal documents. Up to 35 pages each.

Will Preparation

Your provider law firm can assist in the preparation of a Standard Will. Members can receive annual reviews, amendments or updates. The Will may include a codicil or amendment and may include the creation of a testamentary children's trust.

Durable Power of Attorney

Your provider law firm can prepare or review an existing document and amend it once per membership year.

Physician's Directive/Living Will

Your provider law firm can provide a Physician's Directive or Living Will.

Revocable Living Trust¹

The law firm can prepare documents necessary to create a basic revocable living trust once per membership year, for a fee of \$250 each.

Simplified Probate or Summary Estate Administration¹

The law firm will prepare the required court filings with information provided by the personal representative of the estate.

Residential Loan Document Services¹

Your provider law firm will review loan documents required for the purchase of your primary residence once per membership year.

Tenant Lease Assistance

This covers advice, review of documents and negotiation of the residential lease with a landlord.

Uncontested Minor Child Adoption^{1,3}

Services to obtain an uncontested adoption of a minor child.

Uncontested Name Change³

Preparation of the court application and attendance at the initial hearing.

Pre and Post-Nuptial Preparation^{2,3}

Services to obtain a prenuptial or post-nuptial agreement in the member's state.

Uncontested Divorce^{2,3}

Services to obtain an uncontested divorce, uncontested legal separation or uncontested civil annulment.

Traffic Ticket Assistance⁴

Advice and consultation on traffic tickets. For court appearances, 3 per year per member for a flat fee of \$79.

Driver's License Reinstatement

Legal assistance can be provided with an appeal when a driver's license has been suspended, revoked or canceled. Services are limited to two hours of provider law firm time per occurrence.

Defense of Criminal Charges⁴

You can receive defense of charges regarding motor vehicle related services for manslaughter, involuntary manslaughter, negligent homicide or vehicular homicide.

Property Damage Claim

You can receive assistance to collect property damage of \$5,000 or less if you are a driver or passenger or were struck by a motor vehicle.

Civil Trial Defense¹

Your law firm will provide a scheduled number of hours for representation as a defendant in a covered civil action.

IRS Audit Assistance

Receive up to 10 hours of trial time your first membership year for a covered audit, maxing out at 50 hours of trial time after your fifth year when audited by the IRS on your personal tax return.

Discounted Legal Services
